His Excellency the Governor, on the advice of the Minister of Health, and in exercise of the power conferred by section 107B of the Public Health Act 1949, makes the following Regulations:

Citation

1 These Regulations, which amend the Public Health (COVID-19 Emergency Powers) Regulations 2020 (“the principal Regulations”), may be cited as the Public Health (COVID-19 Emergency Powers) Amendment (No. 2) Regulations 2020.

Amends regulation 2

2 In regulation 2 of the principal Regulations, delete the definition of “curfew”.

Revokes regulation 3

3 Regulation 3 of the principal Regulations (night-time curfew) is revoked.

Amends regulation 5

4 Regulation 5(4) of the principal Regulations is amended by deleting “if he considers that there are exceptional circumstances justifying an exemption from this regulation and”.

Revokes regulation 6

5 Regulation 6 of the principal Regulations (opening hours for business or facility) is revoked.

Inserts regulation 6A

6 The principal Regulations are amended by inserting after the revoked regulation 6—

“Bars and clubs to close and all sale of liquor to end at midnight

6A (1) A bar or club shall close no later than midnight, and shall reopen no earlier than 8am.

(2) Subject to paragraph (3), notwithstanding anything in the Liquor Licence Act 1974 or any other provision of law, no business or facility shall sell or serve intoxicating liquor between the hours of midnight and 8am.

(3) Paragraph (2) does not prohibit or restrict the sale in accordance with section 30 of the Liquor Licence Act 1974 of intoxicating liquor to a guest in an hotel between the hours of midnight and 8am, provided the intoxicating liquor is delivered to and consumed in the guest’s sleeping accommodation.

(4) In this regulation—

“club” means a club licensed under the Liquor Licence Act 1974;

“intoxicating liquor” has the meaning given in section 1(1) of the Liquor Licence Act 1974.”.

Revokes regulation 8

7 Regulation 8 of the principal Regulations (restriction on recreational boating activity) is revoked.

Revokes regulation 8A

8 Regulation 8A of the principal Regulations (camping over the Cup Match holiday) is revoked.

Amends regulation 9

9 Regulation 9(2) of the principal Regulations is amended—

(a) by revoking subparagraph (a); and

(b) in paragraph (b), by deleting “other”.
