BERMUDA IMMIGRATION AND PROTECTION (PROHIBITION OF ENTRY) ORDER 2025

BR 1 / 2025

The Minister responsible for immigration, in exercise of the power conferred by section 26(1) of the Bermuda Immigration and Protection Act 1956, makes the following Order:

Citation

1 This Order may be cited as the Bermuda Immigration and Protection (Prohibition of Entry) Order 2025.

Prohibited nationals

2 Subject to paragraph 3, the nationals of the countries provided in the Schedule are prohibited from entering Bermuda.

Prohibited nationals; entry

3 The nationals provided in the Schedule may not enter Bermuda, unless such person—

- (a) has travel authorization to enter and re-enter Canada, the United Kingdom or the United States, with such travel authorization being valid for a period of forty-five days from the date of intended departure from Bermuda; or
- (b) produces a current letter issued by the Government attesting that the person is a spouse of a Bermudian or belongs to Bermuda pursuant to section 11(5) of the Bermuda Constitution Order 1968.
