CHIEF MEDICAL OFFICER (TRANSFER OF FUNCTIONS AND VALIDATION)
ACT 2018

WHEREAS it is expedient to amend various legislation to transfer certain of the Chief Medical Officer's statutory functions to the Chief Environmental Health Officer, the Director of the Department of Health and the Bermuda Health Council and to validate any function the Minister of Health or the Chief Medical Officer purportedly delegated to a public officer or public authority;

Be it enacted by The Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Assembly of Bermuda, and by the authority of the same, as follows:

Citation

1 This Act may be cited as the Chief Medical Officer (Transfer of Functions and Validation) Act 2018.

Transfer of functions

2 The amendments in the Schedule shall have effect to transfer certain statutory functions of the Chief Medical Officer to the Chief Environmental Health Officer, the Director of the Department of Health and the Bermuda Health Council, and to make consequential amendments.

Validation

3 Where, before the commencement of this Act, the Minister of Health or the Chief Medical Officer purportedly delegated any statutory function to a public officer or public authority, any power or duty carried out by such public officer or public authority shall be deemed to have been carried out by the Chief Medical Officer.

Commencement

4 (1) This Act shall come into operation on such day as the Minister may appoint by notice published in the Gazette.

(2) Paragraph 3 and paragraphs 4(d)(iii), 4(l)(i),(ii) 4(m) and 4(o) of the Schedule to the Act shall come into operation on 1 June 2019.
