SCHEDULE  
Fees Chargeable

Her Excellency the Governor, in exercise of the powers conferred by article 4(3) of the Air Navigation (Overseas Territories) Order 2013 (United Kingdom) as applied to Bermuda, makes the following Regulations:

Citation

1 These Regulations may be cited as the Air Navigation (Fees for Certificates and Services) Regulations 2022.

Interpretation

2 In these Regulations—

“the Act” means the Bermuda Civil Aviation Authority Act 2016;

“Authority” means the Bermuda Civil Aviation Authority established by section 3 of the Bermuda Civil Aviation Authority Act 2016;

“Director-General” means the Director-General of the Bermuda Civil Aviation Authority appointed under section 24 of the Bermuda Civil Aviation Authority Act 2016 and whose office is in that Act referred to as “Director-General”;

“investigation” means any investigation, inspection, examination, test, experiment, flying trial, preparatory work, review of documents or any other form of work expended in the consideration of any application;

“Order” means the Air Navigation (Overseas Territories) Order 2013 (United Kingdom).

### Designation by the Governor

3 Pursuant to article 6 of the Order and section 24 of the Act, the Director-General is designated as the person to carry out the functions of the Governor specified in section 4(1)(a) of the Act.

### Applications

4 An application under the Order is to be made to the Director-General.

### Fees chargeable

5 The fees set out in Column 2 of the Schedule are chargeable by and payable to the Authority in relation to the items described in Column 1 of the Schedule.

### Revocation of the 2012 Regulations

6 The Air Navigation (Fees for Certificates and Services) Regulations 2012 are revoked.

### Commencement

7 These Regulations come into operation on 1 May 2022.

(a) Certificate of Airworthiness with a maximum validity of 12 months for aircraft operating under commercial air transport—	
(i) For aircraft not exceeding 5,700 kgs used for Bermuda domestic operations only	\$1,000
(ii) For aircraft not exceeding 5,700 kgs Maximum Take-off Mass (MTOM)	\$8,000
(iii) For aircraft exceeding 5,700 kgs but not exceeding 30,000 kgs MTOM	\$8,000 plus \$175 per 500 kgs or part thereof exceeding 5,700 kgs up to a maximum of \$16,500
(iv) For aircraft exceeding 30,000 kgs but not exceeding 100,000 kgs MTOM	\$16,500 plus \$145 per 500 kgs or part thereof exceeding 30,000 kgs up to a maximum of \$36,000
(v) For aircraft exceeding 100,000 kgs but not exceeding 200,000 kgs MTOM	\$36,000 plus \$135 per 500 kgs or part thereof exceeding 100,000 kgs up to a maximum of \$63,000
(vi) For aircraft exceeding 200,000 kgs but not exceeding 300,000 kgs MTOM	\$63,000 plus \$130 per 500 kgs or part thereof exceeding 200,000 kgs up to a maximum of \$89,000
(vii) For aircraft exceeding 300,000 kgs MTOM	\$89,000 plus \$125 per 500 kgs or part thereof exceeding 300,000 kgs up to a maximum of \$101,500

The fees to be paid by Commercial Air Transport operators of fleets of 80 aircraft or more for a Certificate of Airworthiness shall be those as outlined above less a discount as determined by the Director-General.

(b) Certificate of Airworthiness with a maximum validity of 12 months for aircraft operating under general aviation including corporate operations	\$100 per 500 kg or part thereof*

The Certificate of Airworthiness fee includes the investigation cost.

The actual travel, accommodation and subsistence costs will be charged separately.

(i) For continuing airworthiness management of aircraft operating under commercial air transport	\$3,000*
(ii) For continuing airworthiness management of aircraft operating under general aviation including corporate operations	No charge*
(h) Issue of a “One Time” approval for a maintenance organization and CAMO	\$1,000*
(i) Certificate of Airworthiness for Export	\$100 per 500 kg or part thereof; minimum fee of \$5,000 and maximum of \$70,000*

No refunds will be given if a certificate or approval is subsequently cancelled or if the aircraft is deregistered during the period of validity.
